



#### ANTENNA TOWER PUBLIC NOTICE

AEP Texas Inc. is proposing the constructions and installation of a new 345 foot self-supporting communication tower in Donley County located at 5230 US HWY 70, Clarendon TX, 79226.

FCC Form 854 File No. A1094739 The new tower will be located at Latitude: 35°04' 09.1" N; Longitude: 100° 53' 31.6" in Donley County near Clarendon, TX. The proposed tower is a 325 foot self-supporting tower with appurtenances to a maximum height of 345 feet, and lighting proposed to be dual red/white medium intensity as determined by the FAA (2017-ASW-18975-OE).
