

NOTICE IS HEREBY GIVEN that the City Council of the City of Clarendon, Texas, at its meeting to commence at 7:00 p.m. on April 12, 2018, at its regular meeting place in the City Hall, 119 South Sully Street, Clarendon, Texas, tentatively proposes to adopt an ordinance authorizing the issuance of interest bearing certificates of obligation, in one or more series, for paying all or a portion of the City's contractual obligations incurred in connection with acquiring, constructing, installing and equipping additions, improvements and extensions to the City's waterworks and sewer system, including constructing, installing and equipping water meters, standpipe, and water distribution lines, and paying costs of issuance and legal, fiscal and engineering fees in connection with these projects. The maximum amount of certificates of obligation indebtedness that may be authorized to be sold on said date for such purposes described above is \$2,522,000. The City proposes to provide for the payment of such certificates of obligation from the levy and collection of ad valorem taxes in the City as provided by law, and from a pledge of the surplus net revenues derived from the operation of the City's combined waterworks and sewer system (the ASystem®), remaining after payment of all operation and maintenance expenses thereof, and all debt service, reserve, and other requirements in connection with any of the City's revenue bonds or other obligations (now or hereafter outstanding), which are payable from all or any part of the net revenues of the System.
