





For information about informal review and obtaining property tax records, call your appraisal district at the number listed on the Notice of Appraised Value.

#### Review by the ARB

f you cannot resolve your problem informally with the CAD, you may file a notice of protest requesting to have your case heard by the ARB

The ARB is an independent board of citizens that hears and determines protests regarding property appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes based on evidence heard during the ARB hearing.

If you file a written request for an ARB hearing (notice of protest) before the deadline, the ARB will set your case for a hearing and send you written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening or on a Saturday or Sunday. You may use Comptroller Form 50-132, Property Appraisal - Notice of Protest, to file your written request for an ARB hearing.

Prior to your hearing, you may ask to review the evidence the CAD plans to introduce at the hearing to establish any matter at issue. Before a hearing on a protest or immediately after the hearing begins, you or your agent and the CAD are required to provide each other with a copy of any materials (evidence) intended to be offered or submitted to the ARB at the hearing. Evidence may be submitted for any hearing type either in paper or on a small portable electronic device (such as a CD, USB flash drive or thumb drive) which will be kept by the ARB. Do NOT bring evidence on a smart phone. The ARB's hearing procedures regarding all the requirements to properly submit evidence on a small portable electronic device must be reviewed

To the greatest extent practicable, the hearing will be informal. You or a designated agent may appear in person or you may by telephone conference call or submission of written affidavit to present your evidence, facts and argument.

Not later than May 15 (or within 30 days after a notice of appraised value was

Late protests are allowed for good cause if you miss the usual deadline. The

ARB decides whether you have a good cause. Late protests are not allowed

For change of use (the appraisal district informed you that you are losing

agricultural appraisal because you changed the use of your land), the deadline is not later than the  $30^{\rm th}$  day after the notice of the determination was delivered

after the ARB approves the appraisal records for the year.

#### Deadline for Filing Protest with the ARB\*

#### For ARB changes (the ARB has informed you of a change that

increases yourtax liability and the change did not result from a protest you filed), the deadline is not later than the  $30^{th}{\rm day}$  after the notice of the change was delivered to you

If you believe the CAD or ARB should have sent you a notice and did not, you may file a protest until the day before axes become delinquent (usually February I) or no later than the 125 day after the date you claim you received a tax bill from one or more of the taxing units that tax your property. The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.

CAD not later than the 45th day after you receive notice of the ARB order. If you choose to appeal to the SOAH. you must file an appeal with the CAD not later than the  $30^{th}$  day after you receive notice of the ARB's order. Appeals to district court, binding arbitration or SOAH all require payment of certain fees or deposits.

#### Tax Payment

You must payeither the amount of taxes due on the portion of the taxable value not in dispute, the amount of taxes due on the property under the order from which the appeal is taken or the amount of taxes due in the previous year.
