The Childress District of the Texas Department of Transportation (TxDOT) announced a temporary closure of the SH 203 intersection in Hedley in conjunction with the rehabilitation project currently underway on the northbound lanes of US 287 in Hedley.

The exit is expected to be closed on December 16 and will be closed for around three weeks, weather permitting.

"During the closure drivers can access Hedley via North Bailey Street and McDougal Street," stated Childress Area Engineer Matt Herbstritt. Both roads can also be used by drivers in Hedley needing access to US 287.

The \$8 million highway rehab project is making significant improvements to US 287 through the city limits of Hedley and is expected to be complete by the end of March 2020.

Alert system glitch causes confusion

CC Regents take new vote on president

The Clarendon College Board of Regents this week rescinded a November 21 vote to end the contract of Dr. Robert Riza as president and voted to put him on administrative leave instead.

During a called meeting Monday, December 9, the board without discussion approved a motion reversing their action on November 21, which would have ended the president's contract by December 31. That was followed by a new motion from Regent Carey Wann to place Riza on administrative leave effective immediately "due to some things that have been brought to light recently." That motion was also approved with no discussion.

Last week, the regents met in another called session and met behind closed doors for more than an hour with the college's attorney for an agenda item labeled as "Report from attorney concerning personnel." Earlier in the week, Board Chairman Tommy Waldrop had told the Enterprise the board would receive a report from the attorney concerning Riza's contract. In which case, that agenda item should have been more specific, according to court rulings under the Texas Open Meetings Act. Don R. Richards, a Lubbock attorney serving as an Advisory Director of the Freedom of Information Foundation of Texas, told the Enterprise the wording of last Thursday's agenda item should have specified that regents were going to talk about the president. "The simple use of 'personnel' in the [November 27] agenda clearly appears to me to violate the 'Cox Enterprises' court opinion requiring such specificity with a high-level employee such as college president/superintendent, etc.," Richards said.

The end of at-will employment?

Friday's jobs report once again highlighted the strength of the US labor market. The unemployment rate hit a nearly 50-year low, with the total number of jobs added crushing expectations.

Yet despite another strong indication that the US jobs market is an economic success story, Democratic presidential candidates continue to demand risky and radical plans to overhaul the way Americans work.

Chief among them is Sen. Bernie Sanders. The Vermont senator wants to introduce a slew of changes ranging from a "jobs guarantee" to a hike of the federal minimum wage to \$15 an hour.

But perhaps Sanders' most eyebrow-raising labor market plan is the call to outlaw the American norm of "at-will employment."

Despite US labor-market flexibility delivering much lower unemployment than more heavily regulated countries, Sanders thinks it's time to move toward more onerous employment laws. Getting rid of at-will employment would not only make it much more difficult for inexperienced, young, and risky hires to find work, but it would also reduce wages and living standards.

Democratic presidential candidates continue to demand risky and radical plans to overhaul the way Americans work.

Sanders' goal is laudable but the idea is misguided

Doing away with at-will employment means eliminating the presumption that employers should be able to fire workers at any time or for any reason, just as workers are free to walk away from a job if they choose.

Federal protections against termination already exist for discrimination against protected classes. And many states have additional safeguards for workers, such as laws that prevent companies from firing workers if it would breach implied promises to the employee or is a way to punish the employee for complying with public policies.

Yet Sanders' plan goes much further. He wants a national "just cause" law, where the government would dictate what constitutes a fair layoff for personal or economic reasons, with the threat of court action and fines for employers found guilty of "unjust" dismissals.

His stated desire is laudable: improving job security for workers. But security isn't free.

Making it costlier or riskier to fire people also makes it riskier to hire them. Abolishing at-will employment entirely could make firms less likely to take on workers who are young and inexperienced, particularly when their performance is difficult to observe. The risk of such a law, then, is higher unemployment and weaker labor productivity.

Given that at-will employment is largely the default through the US and Sanders hasn't outlined the precise reasons he'll allow for layoffs, assessing the magnitude of his proposed just-cause law is impossible. But existing evidence from states with even more modest regulations than Sanders' proposal suggests that restrictions on a company's ability to lay

Taking over the field were some 500 protestors from both universities (and a few from other places) with arms liked to indicate concerns about global warming, and several other "gruntles."


Police arrested 42 protesters, and an hour passed before the second half resumed. Time from kick-off to final whistle spanned four hours and 40 minutes....

Many states have an "implied-contract exception" - usually meaning firms can't fire an employee if the company itself failed to deliver on something as set out in a company handbook. A paper analyzing the economic effect of this weaker exception found the regulation lowered a state's employment rate by anywhere between 0.8 and 1.6 percentage points overall, hurting "female, younger, and less-skilled workers," particularly in the short term.

Firms could compensate for the risk burden justcause laws impose by reducing the wages offered to risky hires, negating the unemployment effect. But these results suggest wages aren't fully flexible.

What's more, Senator Sanders wants a \$15 federal minimum wage and the rollout of collective bargaining nationwide, making US wages less flexible still. The combined effect of his plan to reshape the labor market would therefore be doubly damaging for the job prospects of low-skilled, inexperienced workers.

Looking across countries, the impact of less labor market flexibility is clear.

In part because of the flexibility of the US labor market, the unemployment rate has now fallen to an incredibly low 3.5 percent. By contrast, Sweden, Finland, and Denmark – which have variants of the just-cause laws Bernie Sanders proposes - have higher unemployment rates of 6.8 percent, 7.3 percent, and 4.8 percent respectively. Other European countries with much more broadly inflexible labor markets, such as France, Spain, and Italy, have much higher levels of unemployment still.

The experience of the past decade suggests that although flexible labor markets can be volatile in the short term – US unemployment jumped above European levels in 2009 – they near consistently deliver lower structural unemployment over time.

Sanders' agenda doesn't just risk unemployment, though. A just-cause law would likely weaken productivity and hence wages too. Silicon Valley's success has been credited with an ability to hire and fire workers quickly according to a company's needs. Making it difficult to hire and fire leads to workers in jobs to which they are not best suited, or else convinces employers to explore needlessly costly mechanization, reducing their efficiency.

Our labor-market outcomes are not perfect. Many workers want more hours, more security, or higher pay. But Sanders' idea to abolish at-will employment goes too far and will hurt the job prospects of inexperienced workers significantly. Rvan Bourne occupies the R. 

Gatesville is near Fort Hood, one of the largest military installations in the world and the military presence is always in the city.

"Everywhere we go, every event we attend is accompanied by the sounds and sights of freedom," says Gatesville resident Diana Fincher. "In our parking lots we park beside Humvees and big military equipment. We follow their caravans up and down our highways. At our barbeques and backyard picnics, on our golf courses overhead we hear the Blackhawks, the Chinooks. We are so blessed to have that daily reminder of how we are able to be with our families because of their sacrifices."

Diana is involved with organizing social gatherings for reservists and National Guard troops who go for a year of training at North Fort Hood just down the road from Gatesville. Many have done multiple tours of duty and have been recalled.

"These are store owners, mechanics, doctors, lawyers, nurses who have given up their civilian careers and have been called back into military service. I've seen young mothers who



approached the chaplain at North Fort Hood and asked what the community could do to make the soldiers feel welcome.

"He suggested a pot luck supper and maybe just meeting with some of the units. That didn't sound good enough. We wanted to do something really special for the troops. We prepared a Mother's Day barbeque for them. Since then we have gone from a small force of about 40 volunteers and a nice barbeque with a light concert of Texas music, some door prizes and so forth to now when we have over 200 volunteers from our community who want to be a part of recognizing the military. Wherever I go, people want to know when is the next event and how can they help. We call

our celebration the Heart of Texas Salute To Warrior Citizens."

Diana, who taught music in public school for 28 years, has every right to be grateful for the military. Her dad served in the Pacific during World War Two. He met his wife while stationed at Fort Hood.

"Our annual appreciation event takes place on a Sunday afternoon in June. It's like a Texas Country Fair. We bring out all the iconic Texas things like Frito pie, nachos, sausage wrap, funnel cakes and things that we enjoy in our activities around the state. We bring out live Texas Longhorns, we have horseback rides, classic cars, country music, dollars and dollars worth of door prizes and we have an archery range. The reward that we get is what we see happening during the event. Some of them enter with a non-caring attitude and say what is this and why are we here. They have stern military faces and everything is yes, ma'am, no sir. As they leave they're high-fiving us, they're thanking us, they're hugging us. They've had a couple of hours being loved on and acknowledged."

There being no further business, we were dismissed to spread Lionism and good cheer throughout our fair county.





Overview of Medicaid STAR+PLUS

Whether or not a person has health care coverage throughout their life can impact their health and related expenses as they age. Most older adults receive health care coverage through Medicare when they become eligible. However, people who were uninsured before their Medicare eligibility can have higher health care costs and more frequent hospital and doctor visits than those with coverage before Medicare. Medicaid, a jointly funded health care program administered by states, provides health care coverage to vulnerable Texans, including lowincome adults, children and people with disabilities.

In Texas, managed care health plans contract with the state to deliver Medicaid to beneficiaries. Managed care is a health care delivery system

designed to manage quality of care, service coordination. performance and costs.

managed care program that offers prescriptions; Value-added services and supports for adults 21 and older who meet the following criteria: Have a disability and qualify for Medicaid because of low income; Qualify for Supplemental Security Income benefits; or Qualify for Medicaid because they meet a nursing facility-level of care and benefits office, call the 2-1-1 need STAR+PLUS Home and Community Based waiver services because they have an intellectual and developmental disability or related condition.
