CC names committee to review policies

Clarendon College Regents appointed a committee to make policy recommendation to the board when they met in regular session last Thursday, January 16.

CC Interim President Tex Buckhaults said the committee will be looking at policies related to conflicts of interest of board members and other issues with the board's governance of the college that is concerning to the Southern Association of Colleges & Schools Commission on Colleges

A special SACS-COC committee is expected to conduct an on-site evaluation of the college this spring after the accrediting body determined last summer that CC had "failed to demonstrate compliance" with a core **February 12, 2020** requirement and three standards set by the agency.

January 22, 2020

Clarendon City Hall move starts Friday

The City of Clarendon will begin moving this Friday from his historic offices to the new City Hall in the former Lowe Office Building at 313 S. Sully across from the Courthouse

City Administrator David Dockery hopes to complete the move Monday, January 27, and says communication services with the city will be disrupted both Friday and Monday as the appropriate utility companies make the necessary changes. The new City Hall is expected to be fully capable of receiving calls and emails on Tuesday, hold spring elections January 28.

TxDOT closes RR crossings in Hedley

TxDOT's Childress District is closing all three railroad crossings into Hedley from US 287 today. The news comes after another fatal accident this morning in the highway construction zone in that city.

TxDOT says travelers needing to access Hedley from US 287 are advised to take FM 1260 east of Clarendon then take FM 2471 to either FM 1932 or State Highway 273. Justice of the Peace Pat White also advises travelers coming from Memphis can take CR 28 near the Giles rest area and then CR W to enter

January 27, 2020

Childress man dies in Hedley accident

A Childress man died in a traffic accident in Hedley Monday morning, January 27, becoming the third fatality in the US 287 construction zone there and leading the state agency to close crossings there.

Department of Public Safety Trooper Kelly Hill said 46-year-old Ronald Shane Simpkins was pronounced dead at the scene by Justice of the Peace Pat White after his westbound service truck collided with an eastbound semi-truck driven by Calvin Wayne Renfro, 43, of Irving, pulling a double trailer.

Hill said an eastbound pickup truck pulling a trailer was stopped on US 287 preparing to turn north onto

the Bailey Street railroad crossing and another semi-truck was parked behind that vehicle. When Renfro came up on the stopped vehicles suddenly, he "took the wrong evasive action," Hill said, steering to the left into the oncoming westbound traffic.

Simpkins, going westbound, steered to the right when he saw the oncoming semi-truck, and the two vehicles collided in closed lanes which are under construction.

The Bulldogs had climbed as high as number six on the National Junior College Athletic Association poll before slipping back to number 10 this week. The Western Junior College Athletic Association this week has Clarendon number one in the region.

Clarendon opens new City Hall

The City of Clarendon cele-Monday morning after months of planning and renovations.

During an open house, the public had the opportunity to view the spacious new offices for city officials in the building which is formally known as the William J. & Helen Lowe Building. Located at 313 S. Sully across from the Donley County Courthouse, the building was previously the law offices of the late William J. "Bill" Lowe.

City Administrator David Dockery said the new facility provides 3,200 square feet of space compared to the 800 square feet of space municipal offices occupied in the historic City Hall building.

The Lowe Building has been configured to provide a dedicated council chamber with a custom built council table that should more easily accommodate public meetings.

The building also has work and conference rooms, and sizeable dedicated offices for the city administrator, city secretary, and municipal judge.

CC reports lower spring enrollment

Spring enrollment figures at Clarendon College are down after four free throw line hitting 12 out of 16, and ranging from compressing the spring years of record growth.

CC Interim President Tex Buckhaults said total enrollment was 1,441 following the 12th class day last Wednesday, a drop of 2.1 percent from last spring's figure.

Head count on the home campus in Clarendon dropped nine percent from 295 to 268, and the count at the Pampa Center was down about 19 percent from

The Clarendon College District will join the Clarendon Consolidated Independent School District, and the City of Howardwick in holding elections this spring after additional candidates filed to run last week.

With three seats available on the CC Board of Regents, voters have six candidates to choose from on the ballot. Incumbents Darlene Spier and Carey Wann are joined in the race by Guy Ellis, Chris Matthews, Jim Shelton, and Debbie Thompson. One seat on the board is currently vacant following the November resignation of Bill Sansing.

Howardwick also has six people running for three city council seats. Terms of Aldermen Mary Grady and Marietta Baird are seeking re-election, and challengers are Shelly Chavira, Terry Barnes, Jeremy Kindle, and Jada Murray. Alderman Johnny Hubbard did not file for re-election.

Clarendon CISD's Board of Trustees has two positions available this year. Incumbent Reneé Mott has filed for reelection, and Kyle Davis and Chrisi Tucek are also running. Trustee Weldon Sears is not running for another term.

A family on South Carhart Street was lucky to have woken up when a fire started in their house at about 3:40 a.m. last Monday, February 17.

Powell said the blaze was connected to a window heat pump in the home where either the electrical cord shorted out or the machine itself somehow malfunctioned.

March 4, 2020 **Koetting defeats** Wheatly, 104-79

Donley County Precinct 3 Republicans chose a new county commissioner Tuesday, favoring challenger Neil Koetting over incumbent Andy Wheatly, 104-79.

The position was the only competitive local race on the Super Tuesday ballots. Koetting faces no Democratic challenger in the fall and will take over as commissioner in January when Wheatly's term ends.

Also of local interest Tuesday, local Republicans favored keeping District Attorney Luke Inman on the job over his competitor, Bryan Denham, 597-126. Inman was also leading district wide.

In the 15-person race for the Republican nomination for the District 13 congressional seat, Josh Winegarner was the favorite of Donley County voters with 395 votes and Ronny Jackson was second with 184. Winegarner led district wide but did not have enough votes to avoid a runoff with Jackson.

March 11, 2020 Former CC cowboy claims world title

A Clarendon College alumni is the number one saddle bronc rider in the world after winning The American in Arlington Sunday.

Wyatt Casper secured the Saddle Bronc Champion title on the horse, Get Smart, scoring 91.25 and claiming half of the The American's \$1 million prize in AT&T Stadium.

The day before, Casper secured a 91.25-point ride on Onion Ring. His total winnings for The American came to \$600,000.

CC's rodeo program was also represented by sophomore Riggin Smith, the current college national champion. Smith made the final eight round but double grabbed and was bucked off,

said CC rodeo coach Brett Franks.

Bulldogs win Region V championship

The Clarendon College Bulldogs will make their first appearance in the NJCAA National Tournament next week after winning the Region V Championship Saturday in Abilene.

Clarendon is the number three seed in the national tournament. which gets underway next Monday in the keynote speaker, discussing market Hutchinson, Kan. The Bulldogs have a bye in the first round of the tournament and will play at 6 p.m. next Wednesday, March 18, the winner of the matchup between Murray State College out of Tishomingo, Okla., and Cowley College of Arkansas City, Kan.

The Bulldogs secured the NJCAA Region V title by defeating South Plains College of Levelland, 86-80.

NJCAA postpones national tournament

The Clarendon College Bulldogs will have to wait a few weeks to play in their first ever NJCAA national tournament after the association today postponed that event due to concerns about the COVID-19 virus.

CC was supposed to have played in the DI tournament next Wednesday,

In a statement, the NJCAA said it was postponing national championship events for the upcoming DI and DII men's and women's basketball tournaments. DIII men's and women's basketball championships, currently underway, will work with an expedited schedule that will conclude on Friday, March 13.

March 12, 2020 **CC** extends spring break, moves online

Clarendon College is extending spring break, moving most classes online, and canceling spring sports in extraordinary measures to help mitigate the spread of the COVID-19 virus.

In an emergency meeting of the Board of Regents Thursday night, college officials discussed the pandemic in ball over Farwell last Friday night at terms of the safety of students, staff, and

Interim President Tex Buckhaults said the meeting was prompted by the Texas Higher Education Coordinating Board, which had asked colleges and universities to report their plans for dealing with the outbreak. Buckhaults The Broncos shot well from the then presented regents with options lier to not allowing students to return

Dr. John Howard addressed the board in his capacity as the Donley six, Collin Butler added four, and Dono- County Judge and Emergency Management Director as well as a medical doctor. Howard said there were 23 confirmed cases in Texas of COVID-19. commonly called the Coronavirus, as of Thursday with another 100 people being tested in the state. He said the number of confirmed cases would grow by next week, when Clarendon College will be off for spring break.

"The effort now is to mitigate the spread," Howard said. "It is spreading now and spreads rapidly. This is a novel virus. There is no immunity."

March 18, 2020 No plans yet to let school out: STAAR

tests, UIL canceled

Clarendon and Hedley schools have no plans to cancel school as of Tuesday, but are feeling the first impact of the COVID-19 virus with the cancelation of UIL competitions and the upcoming STAAR testing.

With both schools on spring break this week, superintendents said Monday they are taking a "wait and see" approach before extending the break or otherwise canceling classes.

Many schools around the state are already taking measures to suspend classes amid the COVID-19 pandemic, but Clarendon Superintendent Jarod Bellar said no one in Region 16 had done so as of Monday. "Right now we aren't going to

make a determination on that," Bellar said about a possible school closure. "We're here to educate kids and keep them safe, and there won't be a break in that effort." Hedley Superintendent Garrett

Bains said his school was also waiting on any determination to close the school. "As of right now, we're back to

Several local businesses and organizations have this week announced postponements or changes in plans for the weeks ahead.

The Sandell Drive-In Theatre was planning to open for its 2020 season the first weekend in April but announced last week on its Facebook page that it would postpone that opening until further notice.

The Mulkey Theatre is continuing with its movie this week, but the theatre will limit the number of people admitted to the show to 40.

The Saints' Roost Museum board met this week and decided to close the museum until March 31 out of concern for the health of its volunteers. The parishioners of St. Mary's

Catholic Church have postponed their Fish Fry nights scheduled for March 27 and April 3. The church hopes to reschedule those events at a later date.

The Friends of the Library has postponed its Trivia Night that was scheduled Friday, March 27. The group plans to host this event in the future, but no date has been set yet.

March 18, 2020 COVID-19 fears hit local stores

Local businesses are already feeling the impact of COVID-19 even with no cases of the virus yet reported in the Panhandle region.

Reports from other parts of the nation of people stockpiling or hoarding supplies became a reality here late last week when people began buying up local inventories of toilet paper and other goods. Many, if not most, of the buyers were from out of town. Several told an Enterprise correspondent that they were returning from ski trips in the Colorado mountains to their homes in the Dallas and Houston areas. Sources told the Enterprise that

Lowe's Family Center did more business on Friday than it did the day before Thanksgiving, which is typically its busiest time of the year. Limits were put on how many packages of toilet paper and paper towels could be bought on Saturday. On Sunday those limits were extended to most other items in the store when biscuits and eggs started flying off the shelves. Customers are only allowed two of any one item. Tuesday afternoon, Lowe's

shelves were bare of Lysol spray cans and sanitizing hand wipes such as Clorox wipes. Beans, rice, eggs, milk, and bananas were among food items that were quickly disappearing from store shelves.

On Monday, Dollar General released a company statement saying it would dedicate the first hour of each shopping day to senior shoppers, as well as amend store operating hours beginning March 17. Clarendon's Dollar General was also hard hit by people buying up staple goods.

March 19, 2020 Clarendon, Hedley suspend classes

Clarendon and Hedley school officials announced Wednesday evening that they will not allow students to return to classes next week following the spring break holiday as officials work to prevent the spread of COVID-

Superintendents of both schools said classes would be suspended through March 27, and school personnel will be developing ways of delivering educational materials to students going forward. School work will be presented in the form of digital delivery or homework packets or other methods.

Extracurricular activities at both schools are still canceled at this time.

"With the rapidly changing landscape caused by the COVID-19 (Coronavirus), we are continuing to monitor and make adjustments as necessary in order to make educated decisions for the students and staff of CISD," Clarendon CISD Superintendent Jarod Bellar said. "The health and safety of our students, staff, and community are our priority as we navigate this difficult time."

"Please know that this decision does not come lightly," Hedley Superintendent Garrett Bains said. "We recognize that this decision will cause significant difficulties for parents."



Clarendon College Regents named Interim President Texas D. Buckhaults as the lone finalist for the college's top job during their regular meeting last Thursday, May 21.

Board Chairman Tommy Waldrop said at the meeting that the college must now wait 21 days under state law before hiring Buckhaults officially as president. Waldrop said regents could meet in closed session next month to "hash out" any questions and details of a contract.

Clarendon College is receiving \$929,717 from the CARES Act for

expenses related to the COVID-19 pan-

Interim President Tex Buckhaults reported the funding to the Board of Regents during their regular meeting last Thursday.

CC has been approved for the funding in three parts, he said. The first is \$442,844 for students, and CC has identified 362 students who are eligible for the funding. The college is working to contact all of those individuals so they can apply before the deadline at the end of this month. CC will then begin awarding the funds in the first two weeks of June.

The second part of funding is institutional, Buckhaults said, and totals \$442,843. Of that CC has already tapped about \$157,000 for dorm and meal plan refunds for the spring semester. The college also plans to use part of that funding for scheduling software to reduce the need for students to stand in line for registration and financial aid, improved wifi capabilities, an improved text messaging system, and other expenses.

The third part totals \$44,030 and can be used for "strengthening the institution." Buckhaults told the Enterprise that money has not been designated for a specific purpose yet.

Clarendon College has been removed from warning by its accrediting body, according to announcements from the school as well as the Southern Association of Colleges & Schools Commission on Colleges (SACSCOC).

According to information requested from the college by The Clarendon Enterprise, a SACSCOC committee "reviewed extensive documents" and interviewed the board and college president. While the committee found that the college had taken steps to avoid conflict of interest issues with board members, it reported inconsistencies with how the college dealt with conflicts of interest based on responses from members of the board, and it also found the board lacked a "clear operational definition of a conflict of interest for Board members as they apply the policy of the college."

The report also found that the college did not have someone - such as a board officer or president – specifically assigned to be responsible for board accountability, did not offer a structured local orientation for new board members to address conflicts of interest, and was not posting all conflict of interest statements on its website as per its policy.

The City of Clarendon hit a new high for the month and the year when Comptroller Glenn Hegar distributed December sales tax allocations to Texas municipalities.

Clarendon's allocation for the month was \$34,932.58, up 13.35 percent over the same period last year, which had a total of \$30,816.71.

The December allocation pushed the city to a new high for a calendar year with a total of \$445,159.93 for 2020. That figure is more than \$21,000 higher than the \$423,749.33 the city brought in during 2019, an increase of more than five percent.

December 16, 2020 Clarendon looks at new grant projects

The Clarendon City Council approved a resolution authorizing a grant application for sewer line improvements during its regular meeting December 10.

The Community Development Block Grant would replace designated lines and lift stations on the north side of the city, and officials feel confident the city has a strong grant application since it has not received a CDBG grant since

The maximum award under the grant is \$350,000, and the city would be required to have a ten percent match.

NOTICE OF RATE CHANGE REQUEST

On October 13, 2020, Southwestern Electric Power Company (SWEPCO or Company) filed a Petition and Statement of Intent to Change Rates (the Petition) with the Public Utility Commission of Texas (PUC or the Commission) in Docket No. 51415, and with those municipal authorities in its Texas service territory that have original jurisdiction over SWEPCO's electric rates. This notice is being published in accordance with Section 36.103 of the Public Utility Regulatory Act and Commission Procedural Rule 16 Tex. Admin. Code § 22.51(a)(1).

SWEPCO has approximately 187,000 Texas retail customers. All such customers and all classes of customers will be affected by the relief requested in SWEPCO's Petition.

SWEPCO's request to change its rates is based on the financial results for a 12-month test year ending on March 31, 2020. SWEPCO's Petition seeks an overall increase of \$105,026,238, an increase of 30.3% over adjusted Texas retail test year base rate revenues exclusive of fuel and rider revenues. SWEPCO's proposed revenue increase will be offset by a \$14,826,502 decrease in annualized Transmission Cost Recovery Factor (TCRF) and Distribution Cost Recovery Factor (DCRF) revenue. Thus, the net proposed Texas retail revenue increase is \$90,199,736, an increase of 26.0% over adjusted Texas retail test year base rate revenues exclusive of fuel and rider revenues. The overall impact of the rate change, considering both fuel and non-fuel revenues, is a 15.6% increase. The impact of the rate change on various customer classes will vary from the overall impact described in this notice, as shown in the table below. In addition, SWEPCO is seeking recovery of the reasonable rate-case expenses, including expenses paid to reimburse intervening municipalities, that it incurs in this case and those rate-case expenses incurred in three prior dockets that have yet to be recovered.

A Residential Service customer using 1,000 kilowatt-hours of energy per month will see an increase in their total bill (including fuel costs and rate riders) of \$15.71 per month, an increase of approximately 15.0%.




